THE STORES ARE INVOLVED IN RECYCLING AND REPURPOSING MATERIAL THAT WOULD OTHERWISE BE DISCARDED. IN EARLY 2014, WE ESTABLISHED A WASTE AND RECOVERY CENTER AT THE LOCAL LANDFILL WHERE DONATIONS ARE COLLECTED THEN DISTRIBUTED TO OUR RETAIL STORES. THE WARC PROGRAM PROVIDES AN OPPORTUNITY FOR MEMBERS OF OUR COMMUNITY TO ASSISTANT HABITAT FOR HUMANITY IN PROVIDING AFFORDABLE HOUSING IN THURSTON COUNTY WHILE MINIMIZING THE IMPACT ON OUR LANDFILL.
